

SUMMARY ANNUAL REPORT
FOR LIFESPAN RESOURCES 401(K) PLAN

This is a summary of the annual report for the LIFESPAN RESOURCES 401(K) PLAN, EIN 35-1306887, Plan No. 001, for period July 1, 2008 through June 30, 2009. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through insurance. Plan expenses were \$47,374. These expenses included \$47,374 in benefits paid to participants and beneficiaries. A total of 69 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$568,857 as of June 30, 2009, compared to \$618,358 as of July 1, 2008. During the plan year the plan experienced a decrease in its net assets of \$49,501. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$(2,127) including employer contributions of \$54,340, employee contributions of \$38,526, and earnings from investments of \$(107,639).
